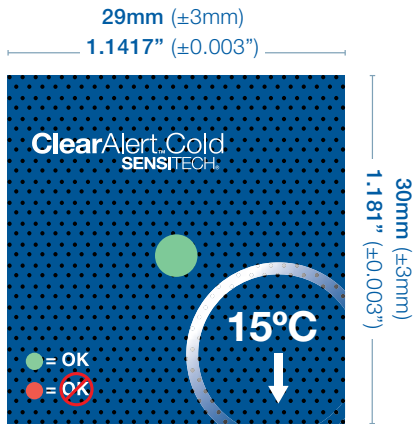
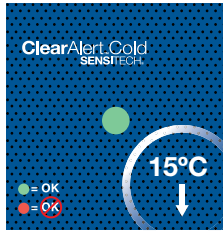

- Bags are labeled with storage instructions
- Bags are shipped inside an insulated shipping container, lined with bubble wrap; heat packs are placed inside the shipping container and outside the bubble wrap
